- PCV membership or Other approved insurance such as EA, AHSA, AERA, HRC AV or interstate pony club member.

- Proof of current membership must be presented at the secretary's desk prior to competing.

## CONDITONS OF ENTRY

1. Entering this competition constitutes acknowledgement that PCV rules apply and acceptance of these rules.
2. All open riders, except PCV current members, MUST sign and submit a Public Liability Waiver Declaration form with entry.  
Riders without adequate Insurance Cover, or a current PCV/EA/HRC AV card cannot be presented, must pay the prescribed fee for Liability Only cover for the duration of the event. (Not personal Medical) and complete the Participant Waiver being \$15. The prescribed Day Attendance Fee is due UNLESS you can prove personal Liability Cover of at least \$10,000,000. **\*Must** produce proof.
3. Before riding current PCV club member cards must be presented at the office for inspection.
4. All riders will need to provide a volunteer.
5. No refunds after closing date except with vet or medical certificate. An admin fee of \$10 will be deducted.
6. The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
7. Competitors may ride more than one horse, subject to the conditions of PCV *Handbook of By-laws* multiple horse rules.
8. Complying helmets must be worn, spot checks may occur.
9. Gear Check: required for **all** riders before each phase. PCA gear rules apply.
10. Medical Armbands optional but highly recommended for riders with medical conditions.
11. Riders under eight years of age may not compete in the horse trials classes.
12. Combined training is for Riders 12 & under only.
13. Horses must be at least age four, no stallions, colts or rigs.
14. Competitor numbers – **All riders must provide their own back numbers and holders.** Competitors may supply their own numbers on bridle or saddlecloth on either side of the horse for dressage and show jumping. However, body numbers must be used for cross-country.
15. PCA approved Body protectors are **mandatory** when jumping fixed obstacles (Cross country) for all ages and grades.
16. Dogs are prohibited without exception.
17. Queries, protests, horse abuse, rules as per the PCV *Handbook of By-Laws*. Protests incur a \$50 fee.
18. Neither the organising committee of this competition nor the PCV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.
19. it is the responsibility of the rider to be available for presentation. Rugs, Ribbons & Prizes not collected will not be posted.
20. Lunging is not permitted.
21. PCV Responsible Alcohol Policy applies.
22. All riders, volunteers and spectators must adhere to all Victorian government COVID-19 policies and restrictions at the time of the event.
